#### Call to Order

The meeting was called to order by Chair Lorimer at 6:37 p.m.

#### Approval of the Agenda

Chair Lorimer called for a motion to approve the agenda as written. So moved by Ms. Thielke and seconded by Mr. Hulak. The motion carried.

# **Approval of the Minutes**

## Report for the City of Shoreline

Ms. Reidy updated the Board members with the following citywide information:

- The 2015 Celebrate Shoreline event was discussed and input was given on the changes made to this year's venue/locations.
- The Library Board's 2015-2016 current term dates, maximum length of terms allowed and how to re-apply were discussed.
- Instructions were given on how to reset the Library Board passwords. Every 90 days they need to be reset. They will be reset tomorrow (9/4) so the Board Members were reminded to go in and change their passwords.
- Ms. Reidy stated that we will soon be using new registration software "Max Galaxy". In the fall we will use a soft roll out and in January 2016 it will go to full use.
- Ms. Reidy shared City of Shoreline's projected growth as requested.

## **Items for Board Discussion**

Breakout Subcommittees: Mr. Hulak is also on the Board of Directors for the KCLS Foundation. He gave some examples of how they use their breakout committees. After some discussion it was decided to continue the breakout subcommittee possibilities discussion after the Boards' new 2015-2016 Goals are set.

**Report on Local Summer Event Activities:** Ms. Bugallo had requested the Board Members report on what local summer activities they went to and reached out to the community as a Library Board Member. Mr. Smith, Ms. Wood-Lim and Ms. Oberg visited the Farmers Market and answered questions from patrons and handed out KCLS goodies/swag.

**Light Rail Station Draft letter:** Ms. Lorimer presented her minor revisions for the letter titled "Light Rail Station Draft letter #3". (Attachment A) The letter was reviewed by Board Members and after discussion, it was decided that the letter was complete. Ms. Wood-Lim called for a motion to approve the letter as written and to proceed to send the letter to Eric Friedli, Parks Director to review. So moved by Ms. Thielke and seconded by Mr. Hulak. The motion carried.

The discussion continued as to what would be the best venue to present the letter. It was decided to send the letter to the KCLS Board of Trustees prior to their public forum meeting on Oct 28<sup>th</sup>. Then the letter would be read as public comment at the meeting which the Chair, Ms. Lorimer will present.

To Gary Wasdin and the Trustees of the King County Library System,

We, the members of the Shoreline Library Board, would like to draw KCLS's attention to two unrelated situations developing in our city:

- Two new light-rail stations, one on either side of the Shoreline library
- The potential addition of 6,000 to 7,000 residents adjacent to the City of

<u>Shoreline</u> at Point Wells <u>in</u> -Snohomish County, who will want to use our library system but will not qualify for borrowing privileges.

We believe that as KCLS begins its next funding and capital bond cycles, we need to ensure that plans for Shoreline are a part of the discussion.

# LIGHT RAIL STATIONS

Two light-rail stations are planned for Shoreline, two miles apart at 145th and 185th Streets. While this area is currently largely single-family homes, the expected rezone will change large parts to allow for new multi-family buildings. The existing Shoreline Library sits right between the two new neighborhoods being created station-areas. Families will move here and need library services for adults, children, and teens: story times, computers to use for school, appropriate collections.

This situation is unique to the KCLS system; nowhere else has a building boom like the one predicted anticipated along the light rail line heading north along I-5: a projected annual growth rate of up to 2.5%. The libraries We believe the KCLS will need to expand services for a quickly growing population.

#### POINT WELLS

Point Wells is in unincorporated Snohomish County, but because of bluffs on two sides and Puget Sound to the west its only road access is through Shoreline, on Richmond Beach Drive. It is being proposed to be rezoned from industrial use to a mixed-use urban center, including 3,000 residential units. The Richmond Beach Library is a short walk from Point Wells, and the route from Point Wells to I-5 runs directly past the



library.

Unless Point Wells makes an arrangement regarding city services with the City of Shoreline, tAs it currently stands the residents of Point Wells will not be eligible for KCLS library cards. However, we expect they will still use library facilities for story time, Study Zone, computers, reference materials, a quiet place to study, and browsing, as we have heard anecdotes of Woodway residents doing (Woodway, also in Snohomish County, does not belong to any library system).

As KCLS begins its next funding and capital bond cycles, we need to ensure that plans for Shoreline are a part of the discussion. KCLS needs a plan for working with

Shoreline's new populations and the projected increased demand for library services that Shoreline's unprecedented population growth will bring.

Shoreline's Environmental Impact Statement (December 2014) predicts a 5.3 percent to 9.9 percent increase in demand for services such as libraries by 2035. Both branches are already overcrowded; we are concerned that increased pressure from growth will make it difficult for future patrons to access the services they need.

We urge the KCLS board to include funding for Shoreline and Richmond Beach Library improvements, and any future branches in our city, in the next round of capital projects. Shoreline's diverse communities support their libraries, and the Shoreline Library Advisory Board is highly invested in being a part of the planning process to accommodate the coming needs of Shoreline.
