# Minutes for the Parks, Recreation and Cultural Services Board / Tree Board Regular Meeting

September 22, 2016 7:00 p.m.

### 1. Call to Order/Attendance

The meeting was called to order by Chair Robertson at 7:00 p.m.

Park Board Members Present: Betsy Robertson, William Franklin, Cindy Dittbrenner, John Hoey, Christine Southwick

City Staff Present: Eric Friedli, Director; Maureen Colaizzi, Parks Projects Coordinator; Kirk Peterson, Parks Maintenance Superintendent; Lynn Gabrieli, Administrative Assistant III

- 2. Approval of Agenda: Chair Robertson moved to approve the agenda as written. So moved by Ms. Dittbrenner; seconded by Ms. Southwick. The motion carried.
- 3. Approval of Minutes: Chair Robertson called for a motion to approve the August 2016 Joint Library and Park Board Meeting minutes. So moved by Ms. Southwick and seconded by Mr. Franklin. The motion carried.
- 4. Approval of Minutes: Chair Robertson called for a motion to approve the August 2016 Regular Park Board Meeting minutes. So moved by Ms. Dittbrenner and seconded by Ms. Southwick. The motion carried.
- 5. Public Comment: None

### 6. Director's Report:

- A new Hangtime program at Einstein Middle School has begun. Hangtime is an after school program that has been operating at Kellogg Middle School for nearly 15 years.
   It is a partnership between the City, school district and YMCA.
- The Community Satisfaction Survey results have been released and are available
  online at www.shorelinewa.gov. Mr. Friedli shared those results directly related to
  Parks. Overall, citizens are very satisfied with Parks and Recreation. The downside is
  that parks-related issues are low on the priority list for funding and attention because
  citizens are content with the way things are. The Board inquired about the frequency
  and validity of the survey measure.
- The King Conservation District Urban Forest Health Assessment is complete for Brugger's Bog, Ballinger Open Space and Innis Arden Reserve, and the Twin Ponds Vegetation Management Plan will be complete this week.
- One bid was received for review and design of the Twin Ponds turf and lighting replacement project. Crumb rubber will be studied for its safety and efficacy and the topic will come back to the Board for discussion.
- Two light poles at Shoreline A & B have been replaced.

- Public Art Coordinator David Francis will host a van tour of local eco-arts projects at Shoreview and Boeing Creek Parks on Saturday, September 24.
- The next Public Art Forum is Thursday, September 29 at City Hall.
- An Art Exhibit and Panel Discussion will take place at City Hall on October 6 and the next Art opening is October 13.

### 7. PROS Plan: Discussion of September 20th Public Meeting

Mr. Friedli distributed handouts of staff summary notes outlining key themes from the September 20 Public Meeting (Attachment A) and reviewed each component. Community comments were also summarized and distributed from the September 20 Public Workshop (available online at www.shorelinewa.gov/prosplan). Board members who attended the workshop reflected on their experience, what they heard, and whether the summarized comments accurately reflected their experience.

The Board offered these reflections:

- Hillwood Park would benefit from an investment of resources,
- Improved signage and more accurate street addresses consistent with Google Maps and other search engines is needed throughout the park system,
- There is a need for more covered picnic areas and improved restroom facilities throughout the City of Shoreline,
- Exercise creativity when looking at existing parcels that could accommodate multiple uses,
- Shoreview Park is one of Shoreline's most prized parks, but lacks amenities that draw
  people to it, safe modes of access to get to it, and it is currently underutilized. All of these
  things make Shoreview an attractive opportunity site,
- Consider activating James Keough Park as a neighborhood park with adjacent parking and restroom and/or other amenities. Consider planting water-loving vegetation/trees to absorb sound from the freeway and mitigate ground water issues.

The next step is to consolidate public feedback into prioritized proposals. A list will be developed and a ranking criteria will be applied. This prioritized list will be presented to the community at the next public meeting on November 1.

### 8. PROS Plan: Aquatics/Community Center Program Outline

Small, medium and large size facilities were considered by the Aquatics/Community Center Subcommittee who reached consensus that an 80,000 square foot facility (medium) could provide adequate amenities to meet the community's needs. The agenda packet outlines the amenities an 80,000 square foot facility could contain.

Mr. Friedli reviewed the components of the plan as contained in the agenda packet. The public workshop on this topic is November 15<sup>th</sup> where siting areas will be discussed, as will program ideas and preliminary designs. The Board acknowledged the challenge of theoretical conversations and the difficulty in being able to imagine possibilities, sizes, impact, and feasibility. Mr. Friedli explained that the feasibility study and operations and maintenance costs will help the community understand the balance between spaces that can be financially offset and those that can't, and clarify what is possible for the Shoreline community.

Ms. Robertson spoke to the absence of a "cultural center" in the preliminary building proposal, and also to the importance of articulating the building's function for purposes of marketing and branding.

The Board asked about the longevity of the building size under consideration when Shoreline is at full buildout. Will it continue to be adequate? Should we consider phases? Do we continue to operate in satellite locations rather than expecting a single building to fulfill all needs?

### 9. Comments from the Board

Mr. Franklin inquired about the status of a future park impact fee. Mr. Friedli responded that a consultant has been selected and will begin working with staff in November, and with the Board and Council early next year.

Mr. Franklin inquired about whether it is possible to offer incentives to developers in exchange for pocket parks or public open spaces. Staff will inquire of the Planning department about Shoreline's plan and process in the light rail areas.

Ms. Schielke requested conversation going forward about tree canopy, tree loss, and tree replacement during the subarea planning process.

Chair Robertson reported on the last Public Art Subcommittee meeting. She shared the committee's frustration and confusion about the interpretation of the 1% for the Arts Ordinance. The subcommittee's position is that the 1% Municipal Fund should not be spent on anything other than permanent art, but monies are currently being spent on temporary art, staff salaries, and other art program expenditures. The committee is interested in creating a more formal process involving the election of a Chair, and she inquired about the process for making that happen.

Chair Robertson reflected that the makeup of the PRCS/Tree Board is heavily weighted on environment and planning expertise but only loosely weighted with expertise and emphasis on the the arts. Board members asked clarifying questions to understand the role and perspective of the subcommittee, and the subcommittee's relationship to the Park Board. Mr. Friedli encouraged further input and discussion about the role of the Public Art Subcommittee and the 1% for the Arts Ordinance in conjunction with the update to the Public Art Plan which will come to the Board in the next few months for discussion and approval.

- Perceived lack of safety
- Lack of innovative recreation features such as spray parks, high ropes course

- Respond to reduction in demand for certain facilities by replacing with facilities growing in demand
- Build a volunteer support system for environmental restoration
- Expand the tree canopy

### THREATS:

- Key park properties are owned by others (school district, State, Seattle City Light)
- Invasive species
- Encroachments from adjacent private property

### **Key Themes**

In addition to completing a SWOT analysis for each park, PRCS Staff reviewed the hundreds of pages of notes taken from the public engagement sessions, the community opinion survey, on-line questionnaire and the September 20<sup>th</sup> community workshop to extract ideas for each park and identified ideas for recreation opportunities that were not tied to a specific park. Several key themes emerged from that analysis:

- 1. Upgrade and enhance existing parks and facilities
- 2. Expand walking and trail-related activities
- 3. Strengthen access to nature
- 4. Add and improve access to aquatics facilities and programs
- 5. Expand indoor exercise and fitness opportunities
- 6. Increase options for adults and seniors
- 7. Support arts and cultural opportunities
- 8. Create multigenerational and multi-cultural opportunities
- 9. Improve access to community gardens and healthy eating
- 10. Add variety across the system
- 11. Manage impacts from future growth
- 12. Continue community partnerships in providing parks, open space and recreation programming
- 13. Increase connectivity parks, recreation and open space facilities
- 14. Improve availability of information
- 15. Improve safety
- 16. Consider Dark Skies Imitative as it relates to lighting within parks
- 17. Consider creating more greenways and wildlife corridors
- 18. Consider more east-west pedestrian/bicycle connections throughout the city to access parks and open spaces
- 19. Consider acquisition opportunities along Aurora Avenue (especially on the west side) to provide park and open space opportunities for future mutli-family residential density in this area.
- 20. Consider better signage: vehicular Wayfinding, trail Wayfinding, entry signage
- 21. Consider expanding leash law enforcement program at all parks
- 22. Consider using demographic and socio economic data when setting priorities for funding capital and recreation programming improvements
- 23. Consider projects that can partner with City departments and other public and private agencies
- 24. Improve accessibility in parks and recreation facilities
- 25. Improve funding to maintain Street/Right of Way trees

Light Rail Station Subarea Parks and Open Space Plan

A preliminary parks and open spaces opportunity map was generated for public review and discussion at the September 20<sup>th</sup> community workshop. The preliminary map shows key concepts that will form the core of the parks and open space plan for the subareas. These include:

- 1. Improve connectivity to recreation opportunities along the 195<sup>th</sup> Street corridor;
- 2. Expand and improve connections to pockets of existing open space along the I-5 corridor; add park and open space property;
- 3. Improve connectivity to recreation and open space on the east side of Interstate 5 (I-5); Add Park and open space property;
- 4. Increase connectivity and water quality near Ronald Bog Park;
- 5. Buffer I-5 noise, air and water pollution through berms, conifers and bioretention facilities; activate James Keogh Park; add special use park and recreation facilities between subareas.
- 6. Look for opportunities for increased play and active recreation between Twin Ponds Park and Meridian Park;
- 7. Protect headwater wetlands, buffer residents from I-5 air, noise and water pollution through berms, conifers and bio retention facilities at Ridgecrest Park. Improve active recreation opportunities;
- 8. Improve water quality upstream of Twin Ponds Park;
- Create art and place-making opportunities, pedestrian/ bike connections and neighborhood open space; expand park and open space property;
- 10. Enhance natural area and pedestrian/bike connectivity through Paramount School Park and Paramount Open Space; as well as expand park and open space property; And, Increase activation, way-finding and natural resource interpretation through Hamlin, South Woods and, potentially, the Fircrest Campus. Align with the Fircrest Master Plan.

### **Requested Board Action**

Staff and the Capital Improvement Planning and Prioritization Subcommittee are requesting input and direction from the PRCS/Tree Board on the draft Capital Improvement Project (CIP) Priority Rating Criteria (Attachment 1) and the draft list of Prioritized Capital Improvement Projects and Master Plan and Studies (Attachment 2 and 3).

### PRCS/Tree Board Review, Discussion and Action

Tonight's presentation will share the draft Prioritized Capital Improvement Recommendations List that has been prepared by staff following the September 20<sup>th</sup> Community Workshop, the September 22<sup>nd</sup> PRCS/Tree Board meeting and the October 18 Capital Improvement Planning & Prioritization Subcommittee meeting.

### Questions for the PRCS/Tree Board's Discussion:

- What are the major themes that are emerging as priorities?
- Do the ranked priorities make sense?
- Is the criteria right?
- Have we applied the criteria to the list of project correctly?

### **Project or Policy Description and Background**

### <u>Draft CIP Priority Rating System and Ranking Process:</u>

The PRCS/Tree Board provided feedback to staff about the Draft CIP Priority Rating Criteria at the June 26<sup>th</sup> meeting including:

- Change Category 7 to address unmet community need;
- Add a new category to address underserved/unserved communities.

Staff generated the capital project list from the ideas generated from:

- Summarized community outreach;
- The asset condition assessments:

The Strengths, Weaknesses, Opportunities and Threats (SWOT) analysis.

After incorporating the PRCS/Tree Board's recommended changes to the CIP Priority Rating System, Staff applied the criteria and ranked the list.

### **Staff Review and Recommendations**

On October 14<sup>th</sup> PRCS staff met to review the list and additional changes were made including:

- Removed the list of projects that call for master plans or studies from the capital project list and recreate a separate list;
- Develop a list of criteria to prioritize Master Plans and studies;
- Apply the criteria and ranked this list.

### PRCS/Tree Board Subcommittee Review

On October 18, members of the Light Rail Station Area Parks & Open Space Plan Subcommittee and the Capital Improvement Planning and Prioritization Subcommittee met to review the Draft Capital Improvement Recommendations List and the Draft Master Plan and Studies List. The following was recommended:

- Present the ranked lists by Securing Our Foundation Projects first, then by Securing our Foundation Projects;
- Modify Category 5 of the CIP Priority Ranking System to address the Communities Unmet Need; and
- Revisit each category and confirm that ratings are consistent throughout.

### Next Steps

After receiving input from the PRCS/Tree Board; staff will prepare a presentation for the November 1<sup>st</sup> community meeting that summarizes the major priorities that have emerged from the prioritization process.



### Parks, Recreation and Cultural Services DRAFT CIP Priority Rating System

### **Rating system**

With eight categories with up to 3 points possible in each category, the total number of points for any one project would be 24.

Site specific vegetation management plans and master plans will be separately evaluated and prioritized in the PROS Plan before added to the 6-year CIP.

### **Project Categories**

Projects are assessed for which categories they fall under. Each category has a rating system of 3-0.

A rating of Three (3) points means that the project completely meets the category and zero (0) points means that the project does not meet the category.

<u>Category 1 – Health & Safety:</u> The project will eliminate a condition that poses a health or safety concern. Examples of a health or safety concerns include a lack of seismic elements, play equipment replacement due to not meeting safety requirements, lighting deficiencies, trail closures due to safety issues, emergency management elements, documented environmental health or safety hazards, crime prevention strategies.

- 3- Documented safety standards are not being met. i.g., documented claims and studies that show the facility is not meeting safety standards
- 2- Safety concern exists; however, there are no documented safety standards.
- 1- Community complaints exists around health & safety conditions
- 0- No Health & Safety conditions exist.

<u>Category 2 – Code Requirements:</u> The project brings a facility or element up to federal, state, and city code requirements or meets other legal requirements. (Note: Projects that are primarily ADA-focused fall under this priority. ADA elements will be completed as part of projects that fall under other priorities.)

- 3- Does not meet code requirements.
- 0- Meets code requirements.

<u>Category 3 – Shovel Ready Projects</u>: Projects identified in supporting plans and other documents that require being done in the upcoming year or has outside available funding to support implementation.

- 3- Project has available funding, is identified in supporting plans and is required to be done in the upcoming year.
- 0- Project does not have available funding, is not identified in supporting plans and is not required to be done in the upcoming year.

<u>Category 4 – Facility Integrity:</u> The project will help keep the facility or park element operational and extend its life cycle by repairing, replacing, and renovating systems and elements of the facility, including building envelope (roof, walls, and windows), electrical, plumbing, irrigation, storm and sewer line replacements, indoor or outdoor lighting, synthetic turf replacement, outdoor trail enhancements.



- 3- Extends life cycle, high usage/heavily programmed.
- 2- Extends life cycle, high usage/programmed.
- 1- Extends life cycle.
- 0- Project is not a repair and replacement renovation project.

<u>Category 5 – Maintain or Improve Operating Efficiency:</u> The project will result in a reduction of operating and maintenance costs or a minimum maintains the existing operating costs. Efficiencies include: energy and water savings or have an opportunity to maintain or increase existing revenue.

- 3- Documented reduction in operating and maintenance costs, including energy and water savings. Has the opportunity to increase revenue.
- 2- Energy and water savings without a known reduction in operating and maintenance costs or staff efficiency. Has the opportunity to maintain revenue.
- 1- Maintaining existing operating costs and/or increase staff efficiency without any change in revenue.
- 0- Increases operating costs with no improved operating efficiency or energy savings. Not associated with revenue.

<u>Category 6 – Projects Meets Environmental, Sustainable or Adopted Plan Goals</u>: Projects that meet adopted plan, environmental, sustainable or larger citywide goals. Documents such as the Recreation Demand Study, Light Rail Station Subarea Park & Open Space Plan, Urban Forest Strategic Plan, Vegetation Management Plans, Master Plans, etc. .

- 3- Is identified in a planning document as a priority.
- 2- Is not separately mentioned in a planning document but is part of the plans implementation goals.
- 1- Not related to a plan but meets citywide goals.
- 0- No unique focus or part of larger citywide goal.

Category 7- Important Community Unmet Need: Projects that improve or meet the unmet facility and/or program needs identified in the 2016 Community Survey .

- 3- Top Priorities: High Importance/High Unmet Need
- 2-Continued Emphasis: Higher importance/Low unmet Need
- 1- Lower Priority: Lower Importance/High Unmet Need
- 0- Lowest Priority: Lower Importance/Low Unmet Need

### Parks, Recreation and Cultural Services DRAFT Master Plans and Studies Priority Rating System

### **Rating system**

With seven categories with up to 3 points possible in each category, the total number of points for any one project would be 21. Site specific vegetation management plans and master plans will be separately evaluated and prioritized in the PROS Plan before added to the 6-year CIP.

### **Project Categories**

Projects are assessed for which categories they fall under. Each category has a rating system of 3-0.

A rating of Three (3) points means that the project completely meets the category and zero (0) points means that the project does not meet the category.

<u>Category 1 Total Project Points:</u> Park Master Plans will first be ranked by total category rating system points, then by total number of capital project points for all capital projects listed for that park or facility from the CIP Priority Rating System.

### Category 2: Neighborhood Park Amenities: Park lacks significant neighborhood park amenities.

- 3 No playgrounds, hard courts or open lawn area
- 2- No picnic areas
- 1- No pathways or loop pathways
- 0- Has neighborhood park amenities

### Category 3: Number of parks/open spaces within neighborhood: The neighborhood lacks neighborhood parks or open spaces.

- 3- Zero to two (0-2)
- 2- Three to four Parks (3-4)
- 1- Five or more parks (5+)
- 0- Not site specific

### <u>Category 4: Recent Investment-</u> Park lacks recent investment.

- 3- No major capital investments in the last 20 years.
- 2- No major capital investments between 12 to 20 years.
- 1- No major capital investments within the last six years
- 0- Received recent capital improvements within the last six years.



### Category 5: Park is within an area of unserved/underserved communities

- 3- Median Household Income below \$50,679.\*
- 2- Median Household Income is between \$50,680 and \$72,537.\*
- 1- Median Household Income is between \$72,538 and \$96,784.\*

<u>Category 7- Community Desire: Adds New Recreation, Public Art or Urban Forestry Capacity:</u> Projects that improve or add capacity to an existing facility that have been identified by the community as important.
