### Meeting Minutes for the Parks, Recreation and Cultural Services Board Meeting

June 28, 2012 7:00 p.m.

Shoreline City Hall Council Chambers

#### 1. Call to Order/Attendance

The meeting was called to order at 7:04 p.m. by Chairman Clements

Park Board Members Present: Boni Biery, Joseph Neiford, William Clements, Carolyn Ballo, Ellen Anderson, Jesse Sycuro

Excused Absence: Kayla Caldwell, Katie Beth, Kevin McAuliffe

City Staff Present: Dick Deal, Director; Lynn Cheeney, Recreation Superintendent; Kirk Peterson, Parks Superintendent; Maureen Colaizzi, Parks Project Coordinator; Lynn Peterson, Administrative Assistant III

#### 2. Approval of Agenda

Chairman Clements called for the motion to approve the agenda as written. Mr. Deal requested that the Kruckeberg bid opening be changed from information to an action item. Permission was granted. The amended agenda was moved to approve by Ms. Ballo and seconded by Ms. Biery. The motion carried.

#### 3. Approval of Minutes

Chairman Clements moved to approve the June 28<sup>th</sup> minutes as written. Moved by Mr. Sycuro and seconded by Ms. Ballo. The motion carried.

#### 4. Public Comment

No public comment

#### 5. Kruckeberg Botanic Garden Bid-Opening

Mr. Deal informed the Board that there was just one bidder for the Kruckeberg Botanic Garden parking lot improvement project. The project manager has contacted the plan holders who did not submit a bid and reported that the reason they chose not to submit related to the complexity of the plan and the tight spaces involved. In addition, pervious concrete pavers are outside of common practice. The bid received is over the engineer's estimate by \$50,000 but the cost to re-bid exceeds any benefit. The Council will review on July 9. Mr. Deal asked for a recommendation to approve the bid by Pelco Construction to the City Council.

Chairman Clements called for the motion to recommend City Council approval of the bid by Pelco Construction for the parking lot improvement to Kruckeberg Botanic Garden. Ms. Ballo so moved. Mr. Neiford seconded. The motion carried with unanimous approval.

#### 6. Sunset School Update

Mr. Deal indicated that staff conducted a walkthrough of the Sunset School site with the School District and Friends of Sunset Park. The School District stated their intention to demolish the facility, leaving the foundation and all else in existing condition. In response to City and citizen feedback, the Shoreline School District is currently working on a proposal that would involve the total removal of facilities and debris. This would allow City funds to be spent on park improvements rather than site cleanup.

The School District prefers to maintain a long-term interest in the property in order to retain the ability to re-activate the property as a school in the future if needed. Mr. Deal intends to return to the Parks Board at the July meeting with a Joint Use Agreement from the School District for review.

Chairman Clements asked the Board to indicate by show of hands if they would like to see the site left clean by the Shoreline School District in order for City monies to be spent on park improvements. The show of hands was unanimous.

#### 7. Echo Lake Park Update

Ms. Colaizzi corrected the agenda packet's Echo Lake Park improvement funding source to reference the King County Trail Levy. Ms. Colaizzi presented a PowerPoint that outlined the park master site planning process to date that includes the public process, meetings with Seattle City Light and consultation with City staff critical area specialists.

The relocation of the restroom to a more visible area is under consideration by Seattle City Light and a property acquisition is still under negotiation. When those two things are resolved the project will be able to move forward. Until then invasive plants can be removed and work parties can be charged with trimming overgrown vegetation.

At the community meeting last week Ms. Colaizzi received input on the current master site plan draft. The current design responds to the community's desire to increase and improve visibility in order to create a safe environment for park users. The design also includes the community's desire for benches with backs, improved water access, relocation and placement of picnic tables into grassy areas, access for fishing and additional shade trees. The Board encouraged the placement of picnic tables around the play areas and the creation of group picnic areas in addition to individual picnicking options.

#### 8. Right of Way Tree Process

Mr. Deal reviewed the process to date for addressing resident requests regarding existing trees in the ROW. Typically a call is made to the City and a determination is made either through GIS or a drive-by whether the tree is, in fact, in the ROW. If the tree is in the ROW the process begins as summarized below:

- Step 1: Permitting
- Step 2: Review by City Staff to determine whether qualifications have been met necessary to grant the request for planting, removal and/or maintenance request
- Step 3: Permit issue
- Step 4: Work will be completed
- Step 5: Maintenance plan and GIS update

Chairman Clements raised questions about the consistency of information on the website regarding which department is responsible for what aspect of tree issues.

#### 11. September meeting

Mr. Deal requested that the September meeting be rescheduled from the 27<sup>th</sup> to the 20<sup>th</sup>. Linden Mead from the Washington State Department of Natural Resources will join us that evening to continue to inform the conversation about Urban Forest Management. **Hearing no objection, the schedule change will be made.** 

#### 12. Staff Reports

Mr. Deal presented for Ms. Bird

- The dedication of the Interurban Mile Markers was held on June 20<sup>th.</sup>
- The Desire Lines project is a temporary art installation that celebrates the paths people naturally take that are off of the designated path to get to where they're going.

#### Mr. Peterson

- Tobacco-free signs have been installed in Shoreline Parks.
- The City's "Forevergreen" logos have been installed on City vehicles that contribute to a healthier environment.
- Hazardous trees at Paramount Park that fell in the wind and rain will be snagged to a safe height.
- Fallen trees on the Interurban Trail by Ballinger Commons were cleared by staff
- A large maple is down over the boardwalk at Innis Arden Reserve M and will be repaired by Earthcorps this summer.
- Maintenance crews are busy power washing bleachers and play equipment in preparation for summer use.
- An abandoned stolen vehicle was left in Hamlin Park.

The Echo Lake Neighborhood Association annual work party will be held July 17<sup>th</sup> from 4-6.

#### Ms. Cheeney

- Camp Shoreline began last week in the pouring rain but is off to a great start regardless. Park Board Member, Ellen Anderson is working as a counselor this year.
   All camps are filled or nearly filled.
- July is Parks and Recreation Month for the City of Shoreline. The Proclamation was received by Lynn Cheeney this year.
- Swinging Summer Eve will be held on July 18 at Cromwell Park.
- Summer Concerts begin in July and continue through August 14. A complete listing is available on the Parks Special Events webpage.
- The Pool is off to a huge start with summer classes. Still accepting registrations for evening and weekend classes. 198 swimmers are registered for the Gators Swim Team.
- Teen Development programs include camps and summer events.
- Karaoke in the Park is a new citizen-driven event at Cromwell Park that is cosponsored by citizens and the City. Admission is 2 cans of food donated to Hopelink. The event begins tomorrow.

Ms. Cheeney's last day will be July 27<sup>th</sup> and the City is in the process of accepting applications to fill the Recreation Superintendent position.

#### Ms. Colaizzi

- Picnic tables, donated by Cleanscapes Waste Reduction Program, have been ordered for the Community Garden gathering area and will be installed by volunteers in August.
- Mountains To Sound Greenway Trust received a grant to restore 2 acres of South Woods Park. The City will be working out the details of that over the next several weeks.

Mr. Deal informed the Board that the Million Stair Challenge was a great success. A BBQ at the bottom of the stairs celebrated the stair climb last week and about 40 people were in attendance. Chairman Clements publicly thanked Mr. Deal for his leadership of this and other community-building Healthy City events sponsored by Shoreline Parks.
