What is the point of requiring conduit and no writing for an EV station? Would the developer still be required to use the EV parking for EV only even without wiring?

DKS contract:

Is all staff time covered by the grant such that there is no fiscal impact to the city? I really question whether the .5 second change is a government make work project rather than a pressing safety need.

A portion of staff time is reimbursable by the grant. The remaining staff time will be handled through the normal course of business.

Just to clarify, reducing the pedestrian walking speed in traffic signal timing equations bring us into compliance with federal ADA and MUTCD recommendations. It is a key component for us being awarded the \$350,000 grant. However, another benefit is that we will have retimed and optimized all of our traffic signals by the end of the year. We do not have the resources to complete such a major project in this time frame without the grant.
