Julie:

Regarding Brugger's Bog:

Previous staff reports have discussed that the properties along Aurora were purchased with grant funds. As a result any amount received on those properties can only be spent on street improvements. Brugger's Bog is not a street improvement, so we have to handle this part of the bond repayment indirectly. The way that we will accomplish this is that in years when Aurora properties sell, those proceeds will go directly to the Roads Capital Fund.

Normally we transfer money from the General Fund to the Roads Capital Fund each year to pay for street projects. In years where we sell properties we will reduce the General Fund transfer for street projects. Instead we will use the proceeds of the property sales to fund those projects. We will use the General Fund money to repay debt instead of transferring the money for street projects.

Please let me know if that explanation is not clear.
