Questionnaire: What would make you more likely to bus, bike, or walk there? What improvements would make you feel safe doing so?

- 1. Space / room to walk confidently near traffic
- 2. Efficient transit connections / better sidewalks and bike lanes
- 3. Bike lockers, restrooms, water fountain, designated bike lanes on access roads & good lighting
- 4. Bike lanes, sidewalks that are safe & separate from cars, frequent busses with good connections
- 5. 5th Ave / Between 175th and 185th the street is narrow /no sidewalk
- 6. Manage High traffic volume. What about guns?
- 7. Good lighting.

## Questionnaire: What other features should be incorporated into pedestrian or bike infrastructure to make them more attractive and functional?

- 1. Bike lane on 5th Ave / landscaping green, grassy areas; well thought out plan for traffic and congestion.
- 2. Covered / Protected walkways across highway (see: can you park?).
- 3. Water fountain, open walking spaces and benches to rest.
- 4. Bike lockers at the station or security cameras directed at bike racks. Well lighted pedestrian walks.
- 5. Crosswalk signals.

Questionnaire: What is the best strategy for managing parking near station areas: structured parking garage, surface parking lot, on-street parking, discouraging people from driving to stations, or other ideas?

- 1. Parking garage. Safe and Secure area; preventative measures against theft.
- 2. Builds less parking. Dedicate / Focus some stations on transit connects w/no commuter parking.
- 3. Garage most efficient use of space. Need to provide to discourage on-street parking.
- 4. A parking garage. The size is difficult to determine. I am at the school if you build it they will come! Traffic, congestion, will be detrimental to the surrounding neighborhoods. I would rather a smaller parking garage to discourage SOV.

# Questionnaire: What are your concerns with regard to transportation and mobility within station areas?

- 1. Again. Well thought out plan for traffic flow; at this point it is relatively very easy to access I5 and I hope that any difficulty will be minimized in the future.
- 2. Gridlock and congestion at station site. System is adding lots of pedestrian, vehicles, transit right at spots already congested. (see 145th and I-5)
- 3. 185th too narrow for increased traffic. Would lose bike lane & mature trees that are valuable. Do not want increased traffic up Perkins way from Kenmore Bothell and Lake Forest Park. Need parking at 145th or bus to 145th.
- 4. Congestion and noise resulting from busier streets. I am concerned with the perennial shortfall of money, for our bus systems. That we will not get the bus service we need for the 185th station that has limited access from the East and North.
- 5. Safety Elevators. Handicapped accessible.
- 6. Elevators, wheelchair accessible, clear signs and directions, posted schedules.
- 7. 155th street should not be considered for a station as it is and always will be too congested of an area. Nothing will change this as it is a residential neighborhood.
