1. Call to Order/Attendance

The meeting was called to order by Vice-Chair Sycuro at 7:00 p.m.

Park Board Members Present: Katie Beth, Vadim Dolgov, Al Wagar, John Hoey, Jesse Sycuro, Betsy Robertson

2. Approval of Agenda: Vice-Chair Sycuro called for a motion to approve the agenda as written. So moved by Ms. Robertson and seconded by Mr. Hoey. The motion carried.

3. Approval of Minutes: Vice-Chair Sycuro called for a motion to approve the February, 2015 Board minutes. So moved by Mr. Wagar and seconded by Mr. Hoey. The motion carried.

4. Public Comment: None

5. Staff Reports

Kirk Peterson, Parks Maintenance

- Wood Duck boxes have been installed at Twin Ponds by Katie Schielke and her daughter. These boxes are part of a statewide tracking program.
- The maintenance staff have been involved in spring cleaning following a mild winter.
- Nearly all citizen open tree requests have been completed by staff and others have been referred to utility contractors for follow-up.
- A homeless encampment was removed from Ronald Bog Park this month.

Mary Anne Kelly, Spartan Recreation Center Manager

- Registration for spring/summer programming began on Monday, March 23. Registrations are up significantly over last year.
- City staff is in the final stages of determining a vendor for new registration software.
- New camps are being offered this summer in addition to traditional Camp Shoreline offerings.
- The pool is up and running following the annual maintenance closure.
- Open positions for camp staff will be posted on the City's website.

Maureen Colaizzi, Park Development

- The Richmond Beach Saltwater Park Pedestrian Bridge project is fully underway. So far the project is on track to be finished by the end of April.
- The Northcrest Park playground equipment replacement project has been completed. EarthCorps is at work removing overgrown vegetation and invasives. The public is invited

to join Mountains to Sound Greenway Trust at a work party on Saturday, April 4 to remove blackberries and recognize Arbor Day.

- Echo Lake Park Improvements were dedicated on Saturday, March 23rd.

David Francis, Public Art

- Active calls for art include: Interurban Artscape (formerly known as Sculpture Stroll), Curatorial Proposals for City Hall Gallery, and Piano Time Sonic Sculpture. All calls and deadlines are posted on the website at shorelinewa.gov/art.
- Several grant proposals have been submitted to fund arts programming.
- Some minor damage/theft has been reported to art pieces such as the piece at Echo Lake Park and one missing mile marker on the Interurban Trail.
- The City contracted for the cleaning of significant bronze sculptures which is anticipated to occur in May.
- About 100 Shorewood High School students toured the City Hall Gallery in March to test student learning on the principles of art.

Director's Report

The City Council subcommittee interviewed seven candidates for three open Parks Board positions. Cindy Dittbrenner, Bill Franklin, and Katie Schielke will be recommended for appointment to the Board on Monday, April 6. Their first Board meeting will be April 23.

6. Mountains to Sound Greenway Trust (MTS)

Tor Bell, Stewardship Director with MTS, provided an overview of the work and mission of MTS Greenway Trust and explained their relationship to the City of Shoreline. Shoreline is part of their Cascade Mountains to Puget Sound greenway target zone. MTS has been actively engaged with organizations and neighborhood groups throughout the City to maintain and enhance green spaces in the midst of population growth and development pressures. In Shoreline they have been involved with invasive species removals and tree planting and they are interested in expanding into educational opportunities and perhaps some projects along the shoreline.

7. Kruckeberg Botanic Garden Annual Report

Brianne Zorn, Executive Director, presented the 2014 year-in-review for the Garden. The Garden's governing foundation partners with the City to provide communitywide programming, including educational camps, tours, and events. Garden staff is continuing to make improvements to the Garden so that it can become even more of an asset to the City in the years to come.

8. Public Art Budget Discussion

Following introductory comments from Public Art Coordinator David Francis that affirmed the sculpture's durability over time, Chair Beth called for the motion to approve the purchase of S.Cargo for addition to the City's permanent public art collection. So moved by Mr. Sycuro and seconded by Ms. Robertson. The motion carried.

Mr. Francis led the Board in a discussion of Shoreline's Public Art program. Given the reality that the public art fund is steadily declining, the Board explored options for how to 1) raise awareness on the City Council through revisions to the Public Art Plan in 2016, 2) engage the public through talking tours, education, and increased exposure, and 3) share the message about what will be lost if funding ceases. The conversation also included broadening the scope to include "the arts" in Shoreline rather than only "public art." Mr. Francis clarified the partnership with the Shoreline Lake Forest Park Arts Council who provides a variety of opportunities for Shoreline residents to participate in many expressions of the arts. The Shoreline Lake Forest Park Arts Council will be invited to a future meeting to clarify the relationship of the Board to the Arts Council. Additional steps were explored to educate the Board, the public and the City Council on existing art opportunities and future possibilities.

9. Comments from the Board

Ms. Robertson stated that she had difficulty finding the Kruckeberg Garden advertisement in the Summer Recreation Guide and she expressed her disappointment that Mr.Lingerfelt was not reappointed to the Board. She also requested the opportunity to recognize outgoing members and welcome new members prior to the next meeting.

Mr. Hoey requested a one month extension to the deadline for the Visit Every Park Challenge and that observations be discussed at the April Parks Board meeting. The Board agreed.

Mr. Sycuro issued a follow up challenge to Board members to attend a neighborhood association meeting to increase community connections.

Ms. Robertson reminded the Board members to wear their nametags next month for the benefit of the new members.

10. Adjournment

Hearing no further business, Chair Beth called for a motion to adjourn. So moved by Ms. Robertson and seconded by Mr. Wagar. The meeting adjourned at 9:05 p.m.

Requested Board Action

Project or Policy Description and Background

In May 2014 the City adopted the Urban Forestry Management Plan. Since that time various steps have been taken to implement key priorities associated with that plan. Most notably the Tree Board went through an extensive process in 2014 to approve the Street Tree List.

In 2014 the maintenance responsibility for all trees on city-owned property was transferred to the Parks Maintenance Division. While parks staff have a great deal of experience working with trees, the addition of trees in the right-of-way has been an additional task.

In order better understand the work load and the level of work associated with tree management we have begun developing regular reports on this work. Attached (Attachment 1) is the first quarterly report that summarizes the work done during the first quarter of 2015.

Requested Board Action

Discussion Item

Project or Policy Description and Background

The Board's Art Committee recommended that as part of the larger discussion of the city's Public Art Fund, it would be good to gain a more complete understanding of the programming offered by the Shoreline Lake Forest Park Arts Council. To that end, David Francis contacted Director Fred Wong, who will offer an overview of the Arts Council's programs and partnership with the Art Program at City Hall.

Budget Implications

The City pays the Arts Council \$60,000 a year for the bulk of public arts programming, as well as a separate fee of \$1,000 for managing three indoor art exhibitions at City Hall in collaboration with the Public Art Coordinator.

Public Involvement Process

The Board's Art Committee is gathering information in preparation for the next five-year update to the city's Public Art Plan (current Plan runs from 2011- 2016).

RE: Cost Recovery/Fees and Charges Framework Project

Requested Board Action

The Board is being requested to provide feedback on an approach to setting cost recovery targets and setting fees and charges for parks and recreation services. The Board will hold a public hearing and be asked to make a recommendation on this topic in June.

Project or Policy Description and Background

PURPOSE:

The purpose of this review is to establish a consistent and equitable framework for setting prices for parks and recreation programs, services, and facility use that balances the community benefit they provide with the desire for financial sustainability.

BACKGROUND:

Recognizing future challenges to the city budget, in 2014, the City Council formed a Subcommittee to develop a 10-Year Financial Sustainability Plan (10 YFSP). The purpose of the 10 YFSP is to strengthen Shoreline's economic base by identifying options to balance revenues with costs.

Staff developed a 10 Year Financial Sustainability Model (10 YFSM) for revenues. They also developed a model for Shoreline's core and quality-of-life services (costs). Over six meetings during the first quarter of 2014, the Subcommittee:

- Discussed the challenges to sustainability;
- Analyzed the City's financial forecast, base scenario, and various economic development, revenue and expenditure strategies;
- Reviewed the City's core and quality-of-life-services;
- Developed preferred alternative strategies; and,
- Finalized recommended alternative strategies for the City Council to consider

The 10 YFSM was recently updated as Council considered the 2014 carryover and 2015 budget amendment requests proposed by staff. The results continue to be promising. When the 10 YFSP was adopted in June 2014 (using 2013 financial information), it appeared that there was a chance that the City could begin to experience a budget gap of \$477,000 in 2019. As a result of working to achieve the sustainability targets set for several of the highest priority strategies the 2015 adopted budget projected that a potential gap of \$580,000 could appear in 2020. Adopting the 2014 carryover and 2015 budget amendment requests creates the potential to experience a budget gap in 2019, although it is projected to be less than half that which was projected in the 10 YFSP.

Staff is now working on the next highest priority strategy identified in the 10 YFSP which is the completion of a detailed cost recovery study in 2015 that could lead to an implementation strategy in 2016. The intent is to:

1. Assess what costs associated with operating PRCS programs, facilities and services are recovered through fees and charges and
2. Determine if higher cost recovery is appropriate or feasible.

PRCS, working with the Administrative Services Department's Budget Office, has developed an approach to this project with three parts:

1. Reviewing cost of services. PRCS and Budget are undertaking a thorough review of what it costs to provide services. The aggregate cost will reflect the costs of: materials, operating the facility, staff, maintenance, and overhead management costs.
2. Establishing cost recovery targets. Attachment 1 describes the conceptual basis for establishing cost recovery targets. This will be the focus of the Board's discussion on April 23rd.
3. Determining price setting protocols. The fair market value may be difficult to measure given the unique nature of many recreation services, but it is possible/common practice to calculate and factor in some assessment of what the buyer is willing to pay into the final fee setting decision.

Key Policy Issues

What is the basis for cost recovery targets?

Public Involvement Process

The Board will hold a Public Hearing at its June 25th meeting. That meeting will be preceded by an article in Shoreline Currents in early June. The public will be asked to provide its thoughts and recommendations on policy options related to cost recovery and fees and charges for parks and recreation services.

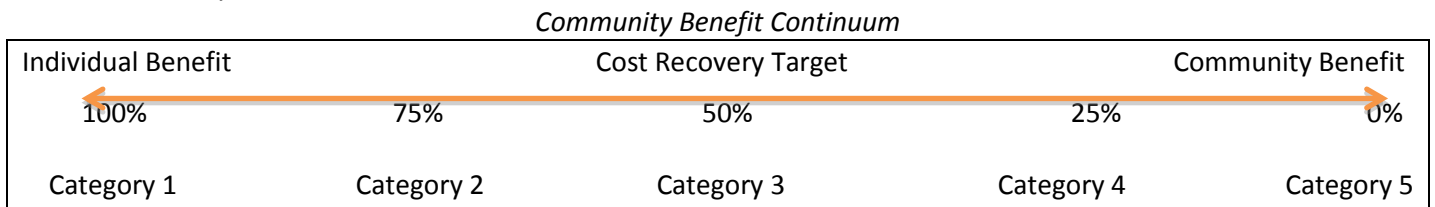

Attachment 1 Conceptual Basis for Cost Recovery Targets

A central component to developing a cost recovery program for recreation services is developing an understanding of the community values and expected outcomes from recreation services. Ultimately the community is paying for services that are not paid for by the individual using the service. When the community is paying then the community ought to be paying for services it values. If a service does not help the community fulfill its vision then the community ought not to pay for it. For example:

- Tiny tot playtime: The community recognizes that one aspect of maintaining healthy families and strong communities is providing an opportunity for parents and small children to get out of the house or apartment and interact with one another. One way of doing that is by having open times for families with small children to drop in for playtime. This is a service that the community sees the value in and is willing to support financially.
- Beer making class: The community recognizes that there is a demand for classes on how to brew beer. These classes serve an adult only audience and, while they do bring people together, are not really focused on community building, personal health and fitness, diverse cultures, or safe neighborhoods. They primarily serve the individual.

The tiny tot playtime and the beer making class are examples of recreation services that are on opposite ends of a continuum from individual benefit to community benefit. The tiny tot playtime is a community benefit program and ought to be highly subsidized by the community and fees charged to the user ought to be minimized. The beer making class is an individual benefit program and should be paid for by the individual and should not be subsidized by the community.



Determining where services fall on the community benefit continuum is not a science. It should be based on how the community values the services and is relative, not absolute. It is made easier by grouping similar services into categories and developing a cost recovery target for each category. The process for assigning services to each category would be based on stated community values and should be validated by a community process, such as a public hearing.
