Thanks for sharing this information.

FYI one of the business owners commenting is a dance and music school owner looking to open a second school in Shoreline, so that may muddy the water a bit for your amendment.

There are also two separate codes for coffee shops, one with drive-thru and one without. I would personally include both, using Café Aroma as an example of a neighborhood café that capitalizes on drive-thru traffic.

I'm not wildly enthusiastic about picking codes like this. I suppose it reduces some of the train wreck. But I think the impact of going from residential (\$6000 currently) to almost any other use (say general services at \$10/sf at 2000 sf for \$20,000, so a TIF of \$14,000) anywhere in rezoned areas remains too tough on small businesses.

And while City Hall seems to be focused on Aurora Square, which could be better but is okay now - it is a shopping center after all - I look mostly east of Aurora. Ridgecrest is still way too quiet, and North City has more than its share of pot shops plus now a gun accessory store. And I worry about who will fill in the first floor of all the mixed use areas in the rezones. And ironically, filling in these areas with a diverse collection of business would reduce traffic because people could walk to places. So... all that keeps me advocating for a 100% exemption for all businesses.
