



Call for Art: Nature and the Machine

The Gallery at City Hall Shoreline in conjunction with Shoreline-Lake Forest Park Arts Council invites submissions for a group exhibition on the general theme of nature and the machine, a juxtaposition of seemingly opposing forces.

Nature and the Machine can accommodate the work of 6-8 artists (5+ works each). Works can be 2D, 3D, installation-based (with total dimensions of maximum 8' in any direction), single-occurrence performances, video, or combinations of these media. Emerging and established artists from across the region are encouraged

to submit. The opening reception is configured as a panel presentation & discussion about the topic and the artist's response.

Artistic and curatorial interpretations are assumed to be broad rather than narrow and we encourage submissions of existing or past work, whether it appears to fit or not. Inquires happily answered and no submission fees charged. Submissions are juried by David Francis, Shoreline Public Art Coordinator; and Lorie Hoffman, Executive Director, Shoreline-Lake Forest Park Arts Council.

Shoreline City Hall is an LEED-Gold building built in 2006. The gallery has about 120 linear feet of wall space, and 5 vitrines on pedestals for small 3D work (2 small: 14" x 14" x 17" h, 2 medium: 17" x 17" h, 1 large: 39" x 19" x 17" h. There is also 1 pedestal with no vitrine.). The Gallery is located on the 3rd floor of City Hall, 17500 Midvale Ave N, Shoreline, WA 98155. We encourage you to stop by and view the space. While the space is secure, the work is not able to be insured during exhibition. Artists are asked to sign a liability waiver.

If accepted to show, all work must be hand delivered – no shipped work will be accepted. All work shown must be original. Commission on sales is 30% with 70% going to Artist and 30% going to Shoreline-LFP Arts Council.
