The City has begun a year-long process to create a Sidewalk Prioritization Plan as directed by the City Council in March 2017. The Council expressed a desire to make improvements to the current sidewalk network, both in constructing new sidewalks (or alternative pedestrian facilities) and maintaining and bringing existing sidewalks up to Americans with Disabilities Act (ADA) standards.

Major components of the process will be to create a data-driven system for prioritizing projects and researching and recommending ways to fund them. The process includes input from a citizen Sidewalk Advisory Committee (SAC) and multiple opportunities for providing public input.

This memo is a brief primer for the January 29, 2018 Dinner Meeting where the Council will hold the first of two dinner meeting presentations with supporting questions from the SAC about key themes that have emerged from the Sidewalk Prioritization Plan/ADA Transition Plan process.

Sidewalk Advisory Committee Overview

In June 2017, through an open solicitation for SAC volunteers, the City Manager appointed 15 citizens to serve on the SAC. The committee consists of members from a diverse cross section of Shoreline neighborhoods with a broad range of interests such as financing, aesthetics, ecology, youth, elderly, access and mobility for people with physical disabilities and from under-represented communities.

Role of the SAC

The SAC's role is to help analyze how to prioritize and fund pedestrian needs for repair of existing sidewalks and installation of new sidewalks or alternative pedestrian treatments. Over a year-long process (see Attachment A for schedule), the SAC will learn more about the condition of the City's existing sidewalks and where gaps exist in the pedestrian network. They will help inform a data-driven mapping process using criteria and metrics to identify needs and prioritize improvements. They will also provide input on a range of alternative sidewalk treatments and look at how the City can financially support the long-term delivery of a city-wide interconnected pedestrian network. At the end of the process, the SAC will provide their findings to the City Manager who will make a recommendation to City Council.

SAC Accomplishments So Far

Since the June 2017 SAC kickoff meeting, the SAC has dedicated time in and outside of committee meetings to advance the project. See Attachment B for a synopsis of the SAC's role and key activities. To date, the SAC's key accomplishments have been the following:

- Informed and tested the draft prioritization criteria.
- Conducted site evaluations in Shoreline of areas in need of improvements.
- Heard and discussed presentations about street trees, alternative sidewalk treatments, ADA compliance, and funding.
- Provided input on draft Open House #1 materials.
- Served as project spokespeople at the Open House #1 by greeting and engaging with the public.
- Provided initial feedback about funding options for repair and maintenance of existing sidewalks and expansion of sidewalk network.

Upcoming SAC Activities

Over the next six months, the SAC will be engaging in the following key activities (see Attachment C for important upcoming dates):

- Considering how the public survey results should inform the process.
- Testing and tuning the prioritization scorecard via data-driven mapping exercises.
- Analyzing funding options.
- Preparing for Open House #2.
- Informing the development of the Sidewalk Prioritization Plan.

Overview of SAC Presentations at the January 29 Council Dinner Meeting

To help inform Council of the key components of the Sidewalk Prioritization Plan/ADA Transition Plan, the SAC formed the subcommittees focused on the following four themes:

- Prioritization Process,
- Communications,
- Sidewalk Treatments, and
- Funding Options.

At the January 29 Council Dinner Meeting, the SAC will introduce the first two out of the four themes. SAC subcommittees will give presentations and ask supporting questions about prioritization process and communications. Below is an outline of the presentations and supporting questions:

A. Prioritization Process Subcommittee - Spokesperson: Dustin McIntyre

- Provide the context of the Transportation Master Plan's Planned Pedestrian System and 2017 Council Goal Setting Workshop
- Explain the data driven prioritization process centered around criteria that reflect City Council Goals and community values
- Highlight how Open House #1 activities and online survey are informing the prioritization process
- Explain the process of testing and tuning the prioritization scorecard

Supporting Questions for Council:

- 1. Does the Council consider neighboring cities' projects, when there's an opportunity to improve connectivity at the borders?
- 2. When faced with two competing projects, one to repair and one is expand, which project should be prioritized? Specific example: repair 5th Avenue NE versus build new facility on Linden or Fremont at N 175th Street?
- 3. Council Goal #4 addresses processes and policies that support equity: how does the Council see sidewalk projects as supporting this goal?

B. Communications Subcommittee - Spokesperson: Andrew Hellman

- Overview of ways to communicate to citizens to build support for sidewalks and their funding:
 - o Elicit and demonstrate participatory interest
 - o Develop a few example sites in different neighborhoods
 - o Appeal to many different types of people

Supporting Questions for Council:

- 1. What does measurable success look like and how do Council and staff demonstrate it to citizens?
- 2. How will Council and staff communicate with citizens to build support?
- 3. How will Council and staff balance competing funding interests (e.g., aquatic center, parks, fire department)?

Upcoming SAC Presentations at the April 9 Council Dinner Meeting

On April 9, SAC subcommittees will give presentations and ask supporting questions about sidewalk treatments and funding options.

What role does the SAC play in the Sidewalk Prioritization Plan?


The SAC is analyzing how to prioritize and fund pedestrian needs for repair of existing sidewalks and installation of new sidewalks or alternative pedestrian treatments. Over the course of the approximately 11 months, the SAC is

- Learning about the City's existing sidewalk conditions and where there are gaps in the pedestrian network
- Discussing pedestrian mobility and accessibility; pedestrian trip generators (e.g. schools, parks, community centers); safety issues/benefits; health and equity; street trees and storm water management; alternative sidewalk treatments; and financing options for implementation
- Informing a data-driven mapping process using criteria to identify needs and prioritize improvements

- Providing input on a range of alternative sidewalk treatments
- Considering how the City can financially support the long-term delivery of a city-wide interconnected pedestrian network
- Using the information presented and discussed over the series of meetings to present their findings to the City Manager who will make final recommendations to the City Council

- Tested and shaped the draft prioritization criteria
