# Minutes for the Parks, Recreation and Cultural Services/Tree Board Regular Meeting

### 1. Call to Order/Attendance

The meeting was called to order by Chair Robertson at 7:00 p.m.

Park Board Members Present: Betsy Robertson, Christina Arcidy, Cindy Dittbrenner, Bill Franklin

Absent: Katie Schielke, John Hoey, Erik Ertsgaard, Christine Southwick

City Staff Present: Director Eric Friedli, Administrative Assistant III Lynn Gabrieli

- 2. Approval of Agenda: Chair Robertson called for approval of the agenda. So moved by Mr. Franklin and seconded by Ms. Arcidy. The motion carried.
- 3. Approval of Minutes: Chair Robertson called for approval of the March minutes. So moved by Ms. Arcidy and seconded by Ms. Dittbrenner. The motion carried.
- 4. Public Comment: None

### 5. Director's Report

- The Aging Adult Services Study is underway. Board members Arcidy and Southwick joined the kickoff meeting on April 9. Ms. Arcidy gave a recap of the meeting
- The Park Funding Advisory Committee recruitment process gets underway next week. Applications
  will be online May 1 through July 13. This committee will be selected by the City Manager and begin
  meeting every three weeks starting in September through March.
- The Public Art Selection Committee met with the first artist last night. Ms. Robertson was present and briefly summarized the 90 minute meeting. Two more artists will be interviewed next week.
- The RFQ for the Community and Aquatics Center closes May 1. Mr. Friedli invited members of the Board to participate in the selection process. Whomever is chosen will perform site-specific design work and provide cost estimates. Mr. Franklin offered to consider being part of the process.
- The annual tour is scheduled for July 26 with tentative plans to tour environmental restoration sites and meet with park stewards at Twin Ponds, Hamlin and Brugger's Bog.
- The August 23 meeting is tentatively scheduled to meet at Kruckeberg Botanic Garden.
- The PRCS/Tree Board is scheduled to participate in the dinner meeting with City Council on June 25.
- The pursuit of accreditation is moving smoothly and on track with 82 out of 151 standards complete. The goal is to finish by the end of 2018 and send the package for external feedback early in 2019.
- Erik Ertsgaard will be recommended for reappointment to the Board for another year. Applications will be accepted through May 18 to fill the vacancy left by Natalia Sandico.

Board officers will be elected at the next meeting.

### 6. Ronald Bog Park Wetland Easement

Mr. Friedli brought the proposed conservation easement before the Board as it is described in the Agenda Packet memo. The easement sets aside wetland buffers within the park to be maintained in perpetuity as wetland mitigation for light rail construction. The Board asked questions about public access and the impact on trees outside of the mitigation area as Light Rail begins to excavate. The public art piece, "The Kiss" will be moved this summer. The Board expressed approval of the design and requested environmental education signage. Mr. Friedli reflected that the message he will deliver to the Planning Department from the Board is that the Board doesn't have any hesitations or modifications and is supportive of the design as presented.

### 7. Concept Design Study

Mr. Friedli led the Board through the most recent concept designs for each of the 8 parks under consideration. After receiving the Board's feedback on these latest designs, the consultants will develop final designs and cost estimates to be reviewed by the public on May 31 at the open house.

### **Brugger's Bog**

- 1. Change "stream typical" to "environmental restoration"
- 2. Remove "paved" and refer just to a loop path. Preference for pervious or natural surface materials **Hamlin Park (Briarcrest)** 
  - 1. Add a tool shed near the community garden
  - 2. Represent the community garden more realistically with pathways between plots and symmetrical design

### **Hamlin Park (North)**

- 1. Play Nest and Widow Bower incorporate into restoration area. Acknowledge the restoration work
- 2. Glad to know the zip line is being removed
- 3. 168th where it intersects with stairs seems like a dangerous access point due to vehicle speed.
- 4. Love the tree house
- 5. Fine with the loop being paved, but would recommend staying away from paving paths deep into the forest. Accessibility issues could be a great conversation with the Sidewalk Advisory Committee to see if there are ways to partner.

Mr. Franklin asked whether the user survey on the Twin Ponds turf infill is complete and asked what the results are. Mr. Friedli reported that the little feedback we received was ambivalent. Shoreline A & B plans call for the installation of cork.

Mr. Franklin recommended the film, "The Social Life of Small Urban Spaces" and wondered whether this could be part of an agenda. Perhaps the Board convenes an hour early for some light dinner food to watch and discuss the film. Staff will consider options for viewing the film this summer.

Ms. Robertson invited other Board members to consider taking a turn as Chair if they feel so inclined.

Hearing no further business, Chair Robertson called for a motion to adjourn. So moved by Ms. Dittbrenner and seconded by Ms. Arcidy. The meeting adjourned at 8:28 p.m.

**RE:** Town Center Public Art Selection

### **Requested Board Action**

The Board is asked to approve the Art Selection Panel's artist recommendation for the public art major commission at the Park at Town Center.

### **Project or Policy Description and Background**

Almost eight months ago (9/19/17), the Art Selection Panel began the process to commission a major new work of public art for the Park at Town Center located northwest of City Hall between Midvale Ave and Aurora Ave.

The Panel is comprised of volunteers from the PRCS/Tree Board (Betsy Robertson, Katie Schielke, and youth member Erik Ertsgaard), the arts community (Tina Lee, Shoreline LFP Arts Council and Exhibitions Manager for SAM; Bruce Amundson; Roger Feldman, retired Chair of SPU Art Department), and community representative (Lara Wesea; formerly with Museum of Glass, Traver Gallery, and Frye Art Museum; also a Parkwood Neighborhood resident).

Staff worked with the panel to draft a Request for Qualifications (RFQ) and conducted a national search for an artist using a variety of outreach methods. The RFQ received interest from 97 artists which the Panel narrowed to a shortlist of 60, and finally a shorter list of six artists that the Panel interviewed by Skype.

Three finalists were offered stipends of \$1,500 to research the site and present more developed proposals:

All three finalists were interviewed by the Panel over the past two weeks. The Panel is in the process of finalizing its recommendation which staff will present to the PRCS Board at the May 24<sup>th</sup> meeting.

The Panel will recommend an artist or artist team to the PRCS/Tree Board whom they believe most demonstrates the capacity to create artwork that meets the community's desires. The final artwork design will be shaped by public process and staff guidance.

### **Public Involvement Process**

The selected artist is expected to engage the community through an open public process to develop the final design for the artwork.

Staff will return to the Board later in the summer to present a final design.

### **Budget Implications**

Funding for the project is reflected in the Council-approved six-year budget adopted as part of the six-year Public Art Plan; there are no changes to the amount of \$140,000. The 1% CIP Aurora Avenue redevelopment contributed the main portion of the funds.

### **Requested Board Action**

The Board is asked to concur with the staff direction of negotiating an agreement with Mountains-to-Sound Greenway Trust for use of an urban forest carbon credit program to fund an urban forest restoration project in Ballinger Open Space.

### **Project or Policy Description and Background**

In October 2017 staff met with John Hoekstra (Executive Director) and Tor Bell (Program Director) from Mountains-to-Sound Greenway Trust (MTS) (<a href="www.mtsgreenway.org">www.mtsgreenway.org</a>). MTS is a non-profit organization whose mission is to "lead and inspire action to conserve and enhance the landscape from Seattle across the Cascade Mountains to Central Washington, ensuring a long-term balance between people and nature." MTS uses creative means and partnerships to preserve natural landscapes. They have led a few volunteer projects in Shoreline over the past several years.

MTS has been working on a new program involving an Urban Forest Carbon Registry (<a href="https://www.cityforestcredits.org/">https://www.cityforestcredits.org/</a>). Knowing that trees store carbon dioxide, the idea is to partner companies interested in offsetting their carbon footprint with urban forestation opportunities. This scenario creates a funding mechanism for investing in the urban forest by companies that want to count the urban forest carbon storage as part of their carbon footprint offset. This is a more common scenario in large forest lands, but has potential for the urban forest as well.

MTS and PRCS Staff have continued to explore urban forest carbon credits as a possible funding source for urban forest restoration work in Shoreline. MTS has suggested to potential funders and the managers of a relatively new Urban Forest Carbon Registry that Shoreline could be a pilot program because of our past relationship with MTS and because the Ballinger Open Space is a severely degraded forest in need of restoration.

MTS approached us very recently with an opportunity for early funding by a corporation that is interested in investing \$50,000+ in an urban forest carbon credit program.

- The upfront cost of doing the restoration work in Ballinger open space is estimated at \$65,000. There would be ongoing maintenance costs of an estimated \$3,000/yr. initially; declining as the restoration plantings establish.
- MTS has provided Shoreline with a draft agreement allowing them to manage the carbon credits on our behalf (see Attachment A). This is the role they desire to play region-wide. Shoreline does not want the role of working directly with the funders and regulators.
- Shoreline's commitment would be to keep the restored forest intact for a 25-year period.

In addition, MTS continues to look for additional funding opportunities to augment the carbon forest credits funding. They are preparing a grant application for the Flood Reduction Fund grant program for Ballinger Open Space.

### **Key Policy Issues**

As part of this project Shoreline would commit to maintaining the use of Ballinger Open Space as an urban forest for 25 years. The draft agreement states:

"Landowner grants The Greenway Trust the title and rights to any and all Carbon+ Credits developed from trees planted in the Ballinger Open Space Project during the term (25 years) of this agreement, including rights to register with CFC, and develop and sell the Carbon+ Credits."

"Landowner shall not cut, harvest, or damage trees in the Ballinger Open Space Project except in cases of emergency involving fire or flooding or to mitigate hazard if trees are identified as a hazard by a certified arborist."

This restriction is similar in nature to restrictions recently approved for the wetland project in Ronald Bog and the restrictions placed on parkland by forward thrust in the 1970's and state grants for purchase and development of park property.

### **Public Involvement Process**

This proposal does not change the use of Ballinger open space, so no special public process is anticipated. Adjacent neighbors will be notified as the restoration work is planned and prior to implementation.

The City Council will review and approve an agreement through its normal public process.

### Outline of Agreement to Transfer Potential Credits

This Agreement to Transfer Potential Credits ("Agreement") is entered in to this
day of, 20 (the "Effective Date") by the City of Shoreline (the
"Landowner") and the Mountains to Sound Greenway Trust, a Washington non-profit
organization ("The Greenway Trust") whose mission is to lead and inspire action to
conserve and enhance the landscape from Seattle across the Cascade Mountains to
Central Washington, ensuring a long-term balance between people and nature. The
Greenway is undertaking a restoration and tree-planting project ("Ballinger Open Space
Project") on the Property of Landowner (the "Property").

### **Purpose and Intent**

The Greenway Trust and Landowner desire to help The Greenway Trust fund this Ballinger Open Space Project by allowing The Greenway Trust to develop potential carbon and environmental credits that it can attempt to sell to defray project costs or to plant additional trees. The Landowner will receive the benefits of the trees planted in this project at little to no cost to the Landowner.

These potential carbon or environmental credits or offsets include amounts of carbon dioxide stored, storm water run-off reductions, energy savings, fish habitat, and air quality benefits arising from the planting and growth of trees in the Ballinger Open Space Project (these credits or offsets are referred to herein as "Carbon+ Credits"). The Carbon+ Credits will be developed using the protocols and registry of City Forest Credits, a non-profit organization ("CFC") based in Seattle.

### Rights Granted

Landowner grants The Greenway Trust the title and rights to any and all Carbon+ Credits developed from trees planted in the Ballinger Open Space Project during the term of this agreement, including rights to register with CFC, and develop and sell the Carbon+ Credits.

### Subject Lands

The Property is specified in Exhibit A.

### **Obligations of Landowner**

Landowner shall not cut, harvest, or damage trees in the Ballinger Open Space Project except in cases of emergency involving fire or flooding or to mitigate hazard if trees are identified as a hazard by a certified arborist.

### **Obligations of the Greenway Trust**

The Greenway Trust will pay all costs and assume all responsibilities for development and sale of Carbon+ Credits from the Ballinger Open Space Project.

### Landowner Representations

Landowner represents that it has authority to enter this agreement, and that the Property is free from any liens, claims, encumbrances, tenancies, restrictions, or easements that would prevent or interfere with the rights to Carbon+ Credits granted under this Agreement.

### The Greenway Trust Representations

The Greenway Trust represents that it has the capacities necessary to execute its obligations under this agreement.

### Default

If either party is in default of this agreement, the other party may notify the defaulting party of the specific nature of the default. The defaulting Party has 30 days from the date of notice to correct the default. If the default is not corrected in 30 days, the non-defaulting party may cancel this agreement. Notice of cancellation shall be delivered in writing to the current contact address of the defaulting party.

### Term of Agreement and Option to Renew

This Agreement shall remain in force for 26 years after the Effective Date of the Agreement. The Greenway Trust may renew this Agreement for a second 26 years if it delivers written notice of renewal to Landowner at least 90 days prior to expiration of this Agreement.

### Governing Law

This agreement shall be construed and enforced in accordance with the laws of the State of Washington.

RE: Capital Improvement Plan (CIP) Review - 2018

### **Requested Board Action**

The Board is asked to concur with the staff-recommended Capital Improvement Plan prioritized lists (Attachment A) to be used as guidance for staff input to the Citywide CIP.

### Project or Policy Description and Background

The PRCS Board and its CIP review subcommittee reviewed the CIP prioritization criteria and draft CIP list in 2016/2017 in preparation for the Parks, Recreation and Open Space Plan adoption. The prioritization criteria and project lists are available in Chapter 6 of the PROS Plan. The CIP projects are divided into categories that are consistent with the way the City develops its CIP. The categorized lists will be used as input to the City's CIP proposal.

The PRCS Board subcommittee met numerous times to review the proposed criteria and various versions of the CIP list in 2016 and 2017. The full board discussed the criteria and draft project lists on June 26 and October 27, 2016 and February 23, 2017. The CIP list(s) were incorporated into the PROS Plan adopted by the City Council in July 2017.

Attachment A presents the prioritized lists with notes highlighting the status of key projects and changes to the list since the PROS Plan adoption.

### Recommended Changes.

<u>Playgrounds</u>: The most notable changes from 2017 are playgrounds at Shoreview, Twin Ponds, Ridgecrest, James Keough and Bruggers Bog which are recommended to be moved onto the priority list as the highest priority. Shoreview, Ridgecrest, James Keough and Bruggers Bog were not included on the priority list in 2017 pending the development of concept designs which are now complete. The concept design project confirmed that it is desirable to retain playgrounds in each of those parks, albeit in different locations. Twin Ponds has moved up the list as its condition has deteriorated. Applying the prioritization criteria places these projects as the highest ranked projects on the list.

PRCS staff will review the possibility of developing a dedicated fund for playground equipment replacement given their high use and replacement schedule predictability.

<u>Shoreline Park Field Lighting:</u> The Shoreline Park field and lighting replacement project was originally identified as a combined project. For budget reasons it was split into two projects in the adopted CIP with the field replacement scheduled in 2018 and the bulk of the light fixtures and pole replacement scheduled for 2020. The replacement of two poles that were in poor condition and the replacement of exiting bulbs was completed in 2017. With that high priority work completed, the priority for the lighting replacement slips down the priority list.

### Firlands Way Green streets project

Boni Biery presented this project to the Board at your February 22, 2018 meeting. It appears on the "Other Great Ideas List" which was included in the PROS Plan to capture a broad range of ideas from the community. Ms. Biery has asked that the Firlands Way Green Street project be moved off of the Other Great Ideas List and become a funded project in the CIP.

Staff does not recommend moving the Firlands Way Green Street to a funded project list on the Parks CIP.

While it is a compelling vision and has many positive attributes, it is only peripherally a park development project. In order for it to become a Parks CIP project, it would have to replace another project on the prioritized list.

### The Board could:

- Recommend the project become a funded project on the parks General Capital CIP list
- Recommend it become a street improvement, sidewalk improvement, or drainage improvement CIP project under the purview of Public Works
- Concur with the staff recommendation and take no action

### **Public Involvement Process**

The CIP will be available for public review and comment through the City Council's adoption process in fall 2018.

# Attachment A CIP Prioritized List by CIP Category – 2018 Review

The City of Shoreline adopts a capital improvement plan (CIP) annually. The Capital Improvement Plan (CIP) is a multi-year plan for capital expenditures needed to restore, improve and expand the City of Shoreline's infrastructure, which includes roads, sidewalks, trails, drainage, parks, and buildings owned and/or maintained by the City. The plan identifies projects and funding for improvements over the next six years and is updated annually to reflect ongoing changes and additions. It also details the work to be done for each project and an expected timeframe for completion.

### **Capital Improvement Fund Descriptions**

The City's Capital Improvement Plan includes four capital funds – two of which are used to fund parks projects. They are:

**GENERAL CAPITAL FUND:** In the General Capital Fund projects are categorized as Facilities Projects, Parks Projects, and Open Space Projects. Funding for these projects is primarily a result of the allocation of General Fund support, real estate excise tax (REET), municipal financing, and grants.

Within the General Capital Fund most projects are identified individually such as replacement of athletic fields, development of master plans, and major trail replacement projects. Parks has a large number of small capital improvement projects that do not warrant being identified in the CIP as separate projects. These are grouped into a Parks Repair and Replacement project and a Parks Ecological restoration Project.

**CITY FACILITIES - MAJOR MAINTENANCE FUND:** In the City Facilities – Major Maintenance fund, projects are categorized as either General Facilities or Parks Facilities.

Funding for these projects is provided by an annual transfer of monies from the General Fund. Park restrooms, the Richmond Highlands Recreation Center, and the Shoreline Pool are included in this fund.

Prioritized CIP Lists have been generated for each of the CIP categories.

- Table 1: Repair and Replacement
- Table 2: General Capital
- Table 3: Facility Maintenance Buildings
- Table 4: Ecological Restoration Program

In addition to the prioritized list for the CIP, there are ideas that were generated through the public process, but not proposed for inclusion in the CIP at this time. They are:
