Background

- On June 18th, the Council discussed policy issues related to a TBD sales tax for sidewalks:
 - o 20 year term at 0.2%
 - Use a conservative list of projects in ballot resolution, not more than 70% of projected revenues
 - Focus funding of new sidewalks and allow flexibility to use a small amount of over-collections for sidewalk repair and retrofits.



Sales Tax

- Transportation Benefit Districts are authorized to impose a sales tax up to 0.2% with voter approval
- The TBD statute allows a term longer than 10 years if the sales tax is dedicated to support debt service

Sales Tax

Estimated revenue generated by the additional sales tax over the 20 year period,

Project List - Scoring

Staff received an inquiry about the scoring of a project and reviewed the ballot measure priority list and the 2018 Sidewalk Prioritization Plan and found

- Projects No. 74, Ballinger Way and No. 35, Dayton Avenue N. had incorrect street classification data
- Project No. 84, 24th Avenue had an adjusted score of 13.5, with no clear reasoning to support the adjustment from the total score of 12.
- Other discrepancies were found that did not affect the ballot measure project list



Project list - Scoring

Staff adjusted two of the projects to facilitate rescoring and development of the ballot measure project list:

- Project No. 35, Dayton Avenue N from Westminster Way N to N 165th Street was broken into three segments;
 - Westminster Way N to N 155th Street (project no. 35a)
 - N 155th Street to N 160th Street (project no. 35b)
 - N 160th Street to N 165th Street (project no. 35c)
- Project No. 84, 24th Avenue with the adjusted score of 13.5, was reset to its total score of 12



Project List - Scoring

After rescoring, the changes to the ballot measure list include:

- Project No. 35b, Dayton Avenue N from N 155th Street to N 160th Street was included in the list
- Project No. 74, Ballinger Way from 19th Ave NE to 25th Ave NE was included in the list (bolded in the table)
- Project No. 84, 24th Ave NE from 15th Ave NE to 5th Ave NE is lower than the cutoff and is no longer included in the list



Project List – Recommendation

Staff recommends that the projects in the prior slide are included in the ballot measure.

- 12 high priority projects
- Geographically distributed,
- About 4.2 miles (22,000 lf) of sidewalk
- Uses approximately 69% of the anticipated available revenue.

Revenue Collected Beyond the Project List

Council expressed interest in using the revenue collected in excess of that used on the projects listed in the ballot to:

- Recommend projects to the City Council for completion based upon the 2018 Pedestrian System Plan
- Address emerging issues
- Allow a small amount for accelerating repairs and retrofits of the existing sidewalk
- Set priorities as part of future Budget and CIP adoption.



Resolution No. 430

As drafted:

- Requires all revenue be dedicated to repayment of Debt;
- Limits use to Pedestrian System Improvements either construction or repair;
- Identifies specific projects that will be completed;
- Provides Council with flexibility to adjust the projects based upon changing priorities or economic changes;
- Provides Council the ability to dedicate some revenue to repair as part of the budget discussions; and
- All projects to be completed must be related to pedestrian improvements and be identified in the Transportation Improvement
 Plan, the Prioritization Plan or Matrix, or the ADA Transition Plan



Recommendation

I move that the City Council approve Resolution No. 430 authorizing placement of a ballot measure on the November 6, 2018 general election ballot to authorize a sales and use tax in the amount of two-tenths of one percent (0.2%) for a period of not more than twenty years to fund sidewalk expansion and accelerate repair funding.

Background

- On April 23 Council asked to develop a resolution to place a voter approved TBD sales tax increase of 0.2 percent on the November 2018 ballot for funding new sidewalks
- On June 4th, the Council approved the 2018 Sidewalk Prioritization Plan
- A summary of the Plan results presented in June is:



Ballot Measure & Resolution

State law requires that the measure be clear on what the voters would be approving, but it does not require a certain level of specificity for individual projects.

- All election documents must be factual and not persuasive
- Description of the measure in the ballot is limited to 75 words
- Explanatory statement is limited to 250 words; can provide more detail
- Resolution also provides more detail on the projects SHORELINE
