1) Written Comment and Traffic Citations, submitted by Andrew Tassani.

9/10/18

Thank you and good evening, my name is Andy Tassani and I live in Lynnwood

On Friday April 6th, I was driving north on Aurora heading home with my 8 year old granddaughter who I had just picked up from the Highland Skating rink

Just past 198th street and before the traffic light at 200th street where I had intended to turn, I was pulled over and ticketed for a violation of the bus lane and for not turning right on 198th street. The officer was actually standing on the curb and seemed to expect cars like mine to be in that lane and quickly took my information and came back with my ticket

Not understanding what I had been ticketed for, I went to see the traffic engineer who informed me that I had to turn right on 198th which is a right turn only street into an apartment complex, and that the city of Shoreline considers that an intersection so the right turn only at that point is required

A note about that is that in Lynnwood where I live, a right turn only lane is defined as from traffic light to traffic light and not the same as Shoreline

I then submitted a public records request to determine how many other drivers may have been ticketed in the very same location on that same day as it seemed to be a kind of traffic trap if you will

I was told that the earliest that I could expect to obtain those records would be in the beginning of September so I decided to proceed to court on the date requested by the court

In the court room, I decided to contest my ticket, and listed 5 different facts including dotted lines where I entered the right hand lane and the definition of an intersection on 198th street. The judge was not so impressed with my argument and restated \$136, pay at the window

Finally, I did receive the requested public records request and much to my surprise, I found that 10 tickets had been written in that same location on the same date and all of them within a 1 hour time period which amounts to one ticket every 6 minutes

I went back to the traffic engineer and asked Kendra to please re-look at this "intersection" because obviously if I didn't understand the ordinance and many others made the same "honest" mistake, it did not seem fair to drivers in Shoreline

Oh, and I stopped into the Police station and thought I might chat with someone in that office who might have found 10 tickets written within a 1 hour period interesting but I was simply told that this was good police work and was an emphasis for the department

So, what is my request?

I would ask the council to please review with traffic whether the stated intersection at 198th street is fairly stipulated or not, and to either change the ordinance or change the signage to make the "intersection" at 198th street more clear

Ps, I don't drive on Aurora any longer and rather go down to Meridian and then go north
