
6.19.1 Fire Investigation


For Beginning in the year 2000, the City may purchase fire investigation services through this agreement. These services will be provided by the King County Department of Development and Environmental Services (DDES) Fire Marshal's Office by separate agreement with the KCSO. The cost for this service is shown on Exhibit B, and will be calculated in accordance with Exhibit G: "Arson Investigation Costing Model." Fire Investigation callouts will be in accordance with protocols outlined in Exhibit H: "Arson Investigation Call Out Protocols," unless superseded by new or revised protocols adopted by the Oversight Committee, DDES and affected fire agencies.







City Managers/Administrators:

Before leaving for his new assignment, Bruce Kalin asked me to ensure that the arson amendment becomes part of each city's ILA with us. John Gerberding of the Prosecutor's Office has advised me to add signature lines to the amendment document for Executive Sims, the city manager, and attorneys (approved as to form), and request that each city provide us with signed copies of that document. The amendment ratification that was signed by 7 of the 13 managers is necessary, but insufficient to make the amendment part of the ILA.

The attached document is identical to the one sent to you by Caroline Whalen and Lori Fleming on December 6, 2001, except that I have added signature lines.

Please print four copies of this document, sign them (you and the city attorney), and return them to me as soon as possible. Upon receipt, I will have our Legal Unit obtain the necessary signatures from the County.
