**Background:**

The State of Washington's Interagency Committee for Outdoor Recreation (IAC) has contacted PRCS to amend their grant contracts for Boeing Creek Park and Twin Ponds Park. These contracts were originally made between King County and the IAC for grants to acquire and develop Boeing Creek and Twin Ponds Park in 1968, 1974 and 1978. At that time, these parks were named "Highland Community Park" and "South Central Shoreline Park". To reflect the currently used names by the City of Shoreline, the three attached amendments will change the names of the IAC contracts to "Boeing Creek Park Acquisition" and "Twin Ponds Park Development" and "Twin Ponds Acquisition".
