

Utility Cross Bore Removals

The City continues to work with utility companies to remove cross bores and repair damaged storm pipes and drains. Please report any known damage to storm pipes during cross boring or other trenchless methods.

As the Surface Water Utility video inspects previously uninspected pipes, it is expected that additional cross bores will be discovered throughout the City.

Staging of Materials in Stormwater Ditches

The City's Municipal Stormwater
Permit prohibits uncontrolled
materials from being placed in our
drainage system. This practice could
lead to water quality, storage
capacity, and runoff conveyance
problems.




Potable Water Discharges to City Right-of-Way Discharges to the City's stormwater system from potable water sources, including but not limited to water line flushing, hyper chlorinated water line flushing, fire hydrant system flushing, and pipeline hydrostatic test water, are conditionally allowed under the City's municipal stormwater permit. Planned discharges shall meeting the following requirements:

- Dechlorinated to a total residual chlorine concentration of 0.1 ppm or less,
- · pH-adjusted (if necessary), and
- Volumetrically and velocity controlled to prevent re-suspension of sediments

 - Construct two multi-lane roundabouts; at the northbound ramp terminals on the west, and at 5th Avenue NE/145th intersection on the west. Re-channelize the existing overpass bridge deck to delete left turn lanes (no longer needed) and add a two-way, 10-foot bike lane adjacent to the existing curb on the north side of the structure
