There was a pro letter 9/14 and another 10/5 before today's orchestrated avalanche.(email from Father Brad urging parishioners to contact the city council to do the right thing and provide shelter.) Did St Luke's house tent cities? They have room. Does it offer emergency housing during cold weather?

This sets off my spidey senses. This does not sound like fair or equal treatment. I know there were letters because I wrote one of them. Right now it appears that opposition quietly died off (not true!) and that there is overwhelming support. I think Council owes the public an explanation of this one-sided posting of letters.
