Here are a few options for ways you can save resources and money, create a healthier workplace, and appeal to customers looking for sustainable businesses.



Pledge to Skip the Straw

We've partnered with the Ocean Conservancy to recognize businesses that reduce waste and protect our oceans by not offering plastic straws. Businesses that take our online pledge to be plastic straw-free will be featured on the City website and social media. You'll also receive a free toolkit that includes a window decal to promote your efforts to customers.

- Make straws available only by request. Only give out a straw if a customer specifically requests one and frequently
 train staff on this policy. Note that disposable flexible plastic straws are still permitted and available for customers who
 need them due to medical or physical conditions.
- **Switch to paper straws.** Paper straws are compostable and a good option for customers who need a to-go straw. Be sure to only purchase approved, compostable paper straws accepted at local composting facilities. For a current list of approved options, visit: **cedar-grove.com/compostable/accepted-items.**
- Add reusable straws to the menu. Does your restaurant have a signature drink? Add a stainless steel, bamboo or glass straw and make it a #SustainableShoreline statement.

2. Choose Reusable over Disposable

Offer reusable plates, bowls, cups and utensils for customers eating at your establishment. Consider compostable options for to-go orders and avoid polystyrene (i.e. Styrofoam™) containers.
