7. Greetings,

I am writing to express my disappointment after listening to this evening's discussion of Ordinance 932 that many of you are under the impression that altering the ordinance for a November ballot would confuse voters. I would argue that the ordinance, as presented in April, was confusing to many voters.

For example, Page 4 (8a-4) states that 3.7 Million dollars are targeted to "Improvement to Acquired Property". My impression, shared by others, that "Improvement to Acquired Property" means improvements to the all acquired properties, including Edwin Pratt Memorial Park and Westminster Park. To exclude these two newly acquired parks from the definition of "acquired parks" in the ballot measure comes across as a less than an accurate portrayal of the ordinance.

If the final decision is to present the same ballot measure to voters in the Fall, I urge City staff to tighten up the measure's language to make it clear that "Improvements to Acquired Properties" only applies to properties acquired in the future, not recently acquired properties.
