

SHORELINE CLIMATE ACTION PLAN UPDATE

The City of Shoreline is working to address climate change and we need your help!

We are updating Shoreline's Climate Action Plan to identify actions the City can take to reduce greenhouse gas emissions and protect our community from the impacts of climate change. Your feedback will help ensure the actions we take to address climate change benefit everyone in Shoreline.

Why are we updating our climate action plan?

According to science-based targets, we need to reduce Shoreline's community-wide greenhouse gas emissions 60% below 2019 levels by 2030 to help prevent the worst impacts of climate change. While we have completed important actions from our 2013 Climate Action Plan, a 2019 inventory shows we are not on track to meet this goal. We need to take bolder action over the next ten years to reduce our emissions. We also need to prepare our community for the impacts of climate change that are already here and those that are projected in the future.

Shoreline is already experiencing impacts from climate change, including:



heavier rainfall and more frequent flooding



more extreme heat days



We have an opportunity to keep these impacts from getting much worse, but we need to act now to significantly reduce our greenhouse gas emissions.


