Action on Ordinance No. 958 – Waiving Council Rule of Procedure 3.6 and Amending Shoreline Municipal Code Section 13.20.040 to Except Temporary Construction Power from the City's Undergrounding Requirement



March 7, 2022

- Council discussed required electrical utility undergrounding in the 145<sup>th</sup> Subarea last week
- Overhead temporary construction power identified as an issue
- Allowance of overhead temporary construction power will address development concerns in the 145<sup>th</sup> Subarea and throughout City

- Adds new Subsection E to SMC 13.20.040 that allows overhead temporary electrical service for construction
- Applies Citywide and to all development projects
- Requires disconnection and removal when project is connected to permanent electrical service or prior to Certificate of Occupancy

### Alternatives

- Narrow allowance for overhead temporary construction power to specific area of the City:
  - 145<sup>th</sup> and 185<sup>th</sup> light rail station subareas
  - MUR-70' Zone



### Tonight's Action

- Recommendation for immediate action given development community needs for construction power
- Waive Council Rule of Procedure 3.6 requiring three readings of Ordinances
- Council Rule of Procedure 6.1.B public comment to follow staff presentation
