# **Neighborhood Program**

### **NEIGHBORHOOD SUPPORT**

The City of Shoreline can help enhance neighborhood associations with innovative assistance including:

- Networking with City programs and speakers
- Coordinating an annual mailing to all residences in the neighborhood
- Arranging meeting space in public buildings
- Brainstorming ideas and projects
- Helping with general publicity (posters, flyers copied, etc.)

### **MINI-GRANTS**

Neighborhood Mini-Grants are available to neighborhood associations for projects which benefit the public and build community spirit. Mini-grants may be used for:

- · Neighborhood improvement projects;
- Increasing awareness of the neighborhood association; or
- Bringing people together to carry out a project or program.

Neighborhood Mini-Grants are approved by the City Council and require a match in volunteer labor or in-kind donations by the neighborhood.

### **COUNCIL OF NEIGHBORHOODS**

The Council of Neighborhoods (CON) consists of two representatives from 14 neighborhood associations within Shoreline. The CON meets monthly to network, learn about other neighborhood happenings and meet with City representatives. This two-way communication allows neighborhood associations to provide community input and the City to present information on upcoming projects.

#### **BLOCK WATCH**
