CM Roberts, Here are the answers to your questions.

1. Would the City still be able to seek out (or receive) safe routes to school grant funding for any of these segments (obviously before completion)? I believe the staff was planning to or has submitted applications for one or all of these segments.

Answer: Yes, the City can still apply for Safe Routes to School funding. And if we were successful it could reduce the amount of General Fund Contribution.

If that is the case, would the transfer from the general fund occur all in the 2023-2024 budget or would a portion of transfer occur in the 2025-2026 budget?
