ORDINANCE NO. 70

AN ORDINANCE OF THE CITY OF SHORELINE, WASHINGTON, ADOPTING THE WASHINGTON MODEL TRAFFIC ORDINANCE (MTO) AS CONTAINED IN THE WASHINGTON ADMINISTRATIVE CODE, CH. 308-330 WAC, AND ADOPTING BY REFERENCE CERTAIN SECTIONS OF CHAPTER 275, LAWS OF 1994 AND RCW 46.20.730 AS AMENDED BY SECTION 23 OF CHAPTER 275, LAWS OF 1994, TO REGULATE TRAFFIC IN THE CITY OF SHORELINE, REPEALING ORDINANCE NO. 27, AND SETTING AN EFFECTIVE DATE FOR THIS ORDINANCE.

WHEREAS, the City of Shoreline by Ordinance No. 27 adopted non-criminal traffic infraction provisions on July 10, 1995; and

WHEREAS, pursuant to an interlocal agreement with King County, the City of Shoreline needs to adopt a code for criminal offenses and non-criminal traffic infractions no later than February 28, 1996; and

WHEREAS, the City of Shoreline wishes to adopt the "Washington Model Traffic Ordinance" for non-criminal traffic infractions and wishes to, therefore, repeal Ordinance No. 27, NOW, THEREFORE,

THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, DOES ORDAIN AS FOLLOWS:

Section 1. Adoption by Reference. The "Washington Model Traffic Ordinance", Ch. 308-330 WAC, except as identified in Section 2 below, is hereby adopted by reference as the traffic ordinance of the City of Shoreline as if set forth in full. Also adopted by reference are Sections 4, 5, 6, 7, 10, 11, 12 and 23 of Chapter 275, Laws of 1994 and RCW 46.20.730 as amended by Section 23 of Chapter 275, Laws of 1994.

Section 2. <u>Sections Not Adopted.</u> The following sections of the MTO are not adopted by reference and are expressly deleted:

Section 3. Repeal. Ordinance No. 27 is hereby repealed effective at 12:01 a.m. on February 28, 1996.

Section 4. Savings Clause. The repeal of Ordinance No. 27 does not affect any traffic infraction or other enforcement action pending in the King County District Court on or before February 28, 1996 and does not operate as an abatement or bar to any action or proceeding pending under or by virtue of the repealed ordinance.

Section 5. <u>Severability</u>. Should any section, paragraph, sentence, clause or phrase of this ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this ordinance be preempted by state or federal law or regulation, such decision or preemption shall not affect the validity of the remaining portions of this ordinance or its application to other persons or circumstances.

Section 6. <u>Effective Date</u>. A summary of this Ordinance consisting of its title shall be published in the official newspaper of the City. This Ordinance shall take effect and be in full force on February 28, 1996 at 12:01 a.m..
