

**ORDINANCE NO. 142**

**AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, AMENDING ORDINANCE NO. 108 AS AMENDED, ADDING A NEW PROJECT TO THE 1995 CAPITAL IMPROVEMENT PLAN, AND AUTHORIZING EXPENDITURES FROM THE SPECIAL CAPITAL IMPROVEMENT FUND**

WHEREAS, the 1997 Budget was adopted in Ordinance No. 108; and

WHEREAS, Ordinance No. 108 was subsequently amended by Ordinance No. 116 (Neighborhood Mini-Grants), Ordinance No. 120 (Highland Plaza Renovation), Ordinance No. 123 (Storm Damage Repairs), Ordinance No. 131 (Completion of 1996 Program Commitments), Ordinance No. 132 (Surface Water and Other Capital Projects), and Ordinance No. 136 (Project Engineers); and

WHEREAS, the City has determined a need to construct additional stairs as a continuation of existing stairs, from the upper shelter pavilion to the view point at the main entrance at Richmond Beach Saltwater Park; and

WHEREAS, these stairs are needed to provide safe access for park visitors who wish to utilize the trail and to control further erosion of the Park slopes; and

WHEREAS, the City Council has, on October 27, 1997, approved this capital project; and

WHEREAS, project specifications have been developed, bid packages have been sent to construction firms, and bids have been received and accepted for this project; and

WHEREAS, the City of Shoreline is required by RCW 35A.33.075 to include all revenues and expenditures for each fund in the adopted budget;

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON, DO ORDAIN AS FOLLOWS:**

**Section 1. Richmond Beach Stairs Capital Improvement Project.** The following new capital improvement project is created: Richmond Beach Stairs.

**Section 2. Capital Improvement Funds Authorized.** The City Manager is hereby authorized to expend up to \$30,560 from the Special Capital Improvement Fund for the Richmond Beach Stairs Capital Improvement Project.

**Section 3. Effective Date.** This ordinance, or a summary thereof, shall be published in the official newspaper and shall take effect five (5) days after the date of publication.
