I. Call to Order and Roll Call

Vice - Chair Lisa Surowiec called the meeting to order. Roll was called.

II. Public Comment

Sheri Ashleman from Richmond Beach Community Association (RBCA) handed out a flyer detailing three meetings in September related to the proposed development at Pt. Wells and encouraged attendance. Ms. Ashleman offered that representatives of the RBCA Pt. Wells subcommittee could come to any neighborhood association meeting to give a presentation.

III. North Corridor High Capacity Transit Project: Extending Mass Transportation from Northgate to Lynnwood

Matt Shelden, North Corridor Light Rail Development Manager for Sound Transit, provided a brief overview of major Sound Transit milestones and projects since its formation in 1996.

Mr. Shelden announced that Sound Transit is planning the extension of High Capacity Transit (HCT) from Northgate to Lynnwood. The project is seeking federal funding and as a result, Sound Transit will conduct an Alternatives Analysis (AA) process to assess alternative modes of transportation and routes as a requirement of the Federal Transit Administration.

Roger Iwata, Community Outreach Corridor Lead for Sound Transit announced there will be three public meetings in October - in Northgate, Shoreline and Lynnwood - which will provide an opportunity for communities to provide formal comments on the project. Information about the public meetings will be mailed as a post card to Shoreline residents at the last week of September.

IV. Summary Recap and Slideshow

Nora Smith, Neighborhood Coordinator, provided a short slideshow recapping major Council of Neighborhoods (CON) summer events including: Swingin' Summer Eve Used Book Sale in July; the second Neighborhood Leaders Potluck; the first ever CON entry into the Celebrate Shoreline Parade; the annual Celebrate Shoreline Carnival Game Tent and the CON work parties on the Interurban Trail.
