

RESOLUTION NO. 135

**A RESOLUTION OF THE CITY OF SHORELINE,
WASHINGTON, AUTHORIZING THE RICHMOND HIGHLANDS
NEIGHBORHOOD ASSOCIATION TO PROCEED WITH
EXPENDITURE OF ITS OFFICE OF NEIGHBORHOODS MINI-
GRANT FUNDS**

WHEREAS, the 1997 budget of the City of Shoreline allocated \$5,000 for neighborhood enhancement in each of Shoreline's 13 neighborhoods; and

WHEREAS, the Office of Neighborhoods Mini-Grant funding provided by the City will be matched by the participating neighborhood in a donation of cash, goods, or labor equal to the value of the City grant funding; and

WHEREAS, the Richmond Highlands Neighborhood Association has submitted a grant application, which has been reviewed by City staff; and

WHEREAS, the Richmond Highlands Neighborhood Association wishes to promote positive recreational activities for youth in Shoreline at the Richmond Highlands Recreation Center and toward that end, has joined together with the youth and staff in a project to paint the Center and provide improvements to the computer lab there. They also wish to provide small appliances, kitchen utensils, recipes and volunteers for the cooking classes held at the Center; and

WHEREAS, the Richmond Highlands Neighborhood Association wishes to further neighborhood enhancement with a fall Neighborhood Cleanup of the neighborhood with activities to include a "swap meet" of unwanted useable items to benefit the Richmond Highlands neighborhood, the Richmond Highlands Recreation Center, the City of Shoreline Parks Programs and Deseret industries; and

WHEREAS, the Richmond Highlands Neighborhood Association wishes to foster community identity and encourage involvement by facilitating the efficient dissemination of information and materials to the residents of the Richmond Highlands neighborhood; and

WHEREAS, Resolution No. 54 requires City Council approval of expenditure of Office of Neighborhoods Mini-Grant funds;

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF
THE CITY OF SHORELINE, WASHINGTON AS FOLLOWS:**

Section 1. Authorization. The City Council hereby approves the expenditure of Office of Neighborhoods Mini-Grant funding for the Richmond Highlands Neighborhood


Association projects of enhancements to the cooking classes and the computer lab at the Richmond Highlands Recreation Center, painting of the Center, a fall neighborhood cleanup and "swap meet" and neighborhood communication.
