

RESOLUTION NO. 231

A RESOLUTION OF THE CITY OF SHORELINE, WASHINGTON, ADOPTING THE PARKS RECREATION AND OPEN SPACE MASTER PLAN

WHEREAS, Shoreline's first Parks, Open Space, and Recreation Services Plan was adopted in conjunction with the City's first Comprehensive Plan on November 23, 1998; and

WHEREAS, in 2003 City Council directed staff to undertake development of master plans for Parks Recreation and Open Space (PROS), Transportation, and Surface Water in conjunction with the Major Update of the Comprehensive Plan to take advantage of coordinated process and review; and

WHEREAS, an extensive public participation process was conducted to develop and review the PROS Master Plan:

- May & June 2003 Stakeholder Interviews with Shoreline School District, Shoreline Community College, and City of Shoreline Park Maintenance Staff.
- Focus Group formation with the PRCS Board, YMCA, Cascade Swim Club, Shoreline Historical Museum, Shoreline-Lake Forest Park Arts Council, Richmond Little League, North King County Little League, Council of Neighborhoods, Shorelake Soccer Club, Shoreline-Lake Forest Park Senior Center, and Shoreline Citizens.
- May & June 2003 PROS Plan Citizen Survey of 576 random households to determine priorities for future development of parks and recreation facilities.
- September 2003 two community open houses were held
- September & October 2003 Bond Advisory Committee Survey of 500 random households helped determine elements to be considered for a bond issue and what level of community support.
- June 2003 to March 2004 PRCS Board reviewed Levels of Service, the goals and policies, the 20-year capital project list, and conceptual plans for projects.
- May 2004 Public open house and first draft of PROS Plan released for public review.
- July to September 2004 PRCS Board, Planning Commission, Citizen review and input.
- November 2004 Planning Commission recommended draft plans published for public review. The PROS plan was updated based on public input and PRCS Board and Planning Commission recommendations.
- December 2004 to May 2005 City Council conducts additional public hearings and reviews plans.

WHEREAS, a SEPA Determination of Non-significance was issued on September 14, 2004 for the adoption of the Parks Recreation and Open Space Master Plan; and

WHEREAS, the Planning Commission conducted a Public Hearing on the Updated Comprehensive Plan, PROS Plan, Transportation Master Plan, and Surface Water Master Plan on September 28, 29, 30, 2004; and


WHEREAS, the Planning Commission unanimously recommended approval of the Updated Comprehensive Plan, PROS Plan, Transportation Master Plan, and Surface Water Master Plan on November 4, 2004; and

WHEREAS, the City Council conducted a public hearings on the Updated Comprehensive Plan, PROS Plan, Transportation Master Plan, and Surface Water Master Plan on December 13, 2004, January 10, 2005, and February 14, 2005;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SHORELINE, WASHINGTON AS FOLLOWS:

Section 1. The Parks Recreation and Open Space Master Plan published in the fall of 2004, amended on May 23, 2005, and given Clerk's Receiving Number 3441 is hereby adopted.
