### I. Call to Order and Roll Call

Chair Arthur Peach called the meeting to order. Roll was called.

**II. Public Comment:** Frank Moll asked the members to assist him and the committee planning this year's Veteran's Day Celebration by using their various communication channels to publicize the event. They are looking to increase the attendance beyond the 120-150 who attended in 2010.

Patty Hale presented a proposal for the CON and neighborhoods participate in "Shoreline Walks 4 Health" on May 7. Ms. Hale noted that was a chance for neighborhoods and CON to gain some visibility with young families; she will be coordinating the volunteer effort and will follow up with those who indicate a willingness to volunteer. Rob Beem described the event noting that it is the first highly visible activity in the City's Healthy City Strategy.

- III. Capital Improvement Plan: Tricia Junke, CIP Manager, Public Works Department. Ms. Junke reviewed the process and structure of the Capital Improvement Plan (CIP). This is an annual budgeting exercise that looks out six years. The CIP is divided into four sections which address 1) Roads, 2) General Capital, e.g. parks and City Hall, 3) Surface Water and 4) Facility Maintenance. Items and projects included in the CIP all relate to one of a number of city adopted master plans such as the Surface Water or Transportation Master Plan. Ms Junke then reviewed specific projects included in the current CIP. This year the City Council will be considering and adopting the CIP in June.
- **IV.** Formation of the Nominating Committee. Chair Arthur Peach discussed the need to for a nominating committee to solicit candidates for board positions. The committee is to present its recommendations at the May CON Board meeting. Judy Allen, Afia Menke and Gretchen Atkinson agreed to serve as the nominating committee.
